- 5. Consignors shall pay a fee equal to 25% of the asking price for early removal of any consigned items.
- 6. Furniture Buy Consignment is not responsible for any damage, theft or loss of any items consigned.
- 7. Earnings are available upon request, 15 days after the date of sale. Checks shall be mailed to the address on this agreement. Consignors shall be responsible for any costs associated with lost, stolen or replacement checks. Earnings may be used towards purchases at any time.
- 8. Unclaimed consignor earnings shall be forfeited 6 months following the expiration date of this agreement.
- All consignments must be in very good to excellent condition. Consignors shall be charged for any cleaning and repair charges deemed necessary by the consignee.
- Please inquire about consignments periodically. Feel free to call, email us or stop by the store for updates on the status of your account.
- 11. Unsold and/or unclaimed Consignments can be donated to charity on your behalf 30-days after the consignment expiration date.
