1. This agreement is between the consignor and a single Furniture Buy Consignment location. The above-named person (the consignor) authorizes Furniture Buy Consignment (the consignee) to sell all items described in this agreement and any subsequent consignment addendums. All consignments are for sale while in our possession.
2. The term of this agreement is for 60 days. The consignee reserves the right to extend the term beyond the expiration date.
3. Consignors may claim unsold consignments upon the expiration date. Unsold or unclaimed consignments can be donated to charity on behalf of the consignor 30 days after the expiration date.
4. Consignors receive 50% of the selling price for consignments sold in the first 60 days. Furniture Buy Consignment shall receive an additional 10% for consignments sold after 60 days.
5. Furniture Buy Consignment shall accept reasonable offers at any time. Consignments are subject to the following price reductions, which affect the consignor's earnings: 15% after 30 days, 25% after 60 days, 40% after 75 days, and 50% or greater after 90 days.
6. Consignors who wish to remove any consigned items early must pay 25% of the asking price.
7. Furniture Buy Consignment is not responsible for any damage, theft, or loss of any items consigned.
8. Consignor checks are issued upon request and mailed to the address on file. A \$3 fee is deducted from the consignor's proceeds for each check. Replacement checks for any delayed, lost, or stolen checks may be requested 30 days after the date the check was issued. Consignors are responsible for any costs associated with stopping payment or reissuing a consignor check. Consignor earnings can always be used as store credit and applied towards purchases at any of our locations.
9. Unclaimed consignor earnings shall be forfeited 6 months following the expiration date of this agreement.
10. All consignments must be in very good to excellent condition. The consignee will charge the consignor a fee for any cleaning or repairs deemed necessary.
11. Please log in to our online portal to view recently sold items. The portal only displays sold items. Please communicate with us periodically for updates on the status of your consignments.
12. I am the sole owner of the items described below and am within my legal rights to consign and transact these items. I have read, understood, and fully agree to the terms and conditions of this agreement.
